Working with residents to tackle car parking issues

Following a number of issues relating to parking in a private car park for residents at Zetland Mews, we agreed to mark the bays more clearly to indicate where the parking was.

The lines and colours used had to be in keeping with the listed status of the building and the local council offered advice on how to proceed. This simple solution will ensure that residents clearly know where to park their vehicles in future.

Our scheme at St Hilda's in Whitby has a car park with areas of shrub planting which have deteriorated over a number of years.

After speaking to residents, we have re-planted the shrub beds next to the car parks and the raised planters on the walls. We also carried out a general tidy-up to improve the overall condition of the area.

Home improvements

Ornamental archway

Residents told us that they had concerns about the safety and appearance of a gate and an ornamental archway at Gresley Court in Saltburn.

We listened to those concerns and have agreed to paint and repair them to help improve the local environment for residents.
